The Cancer Burden in the World & Europe

- The burden of cancer continues to increase. The strain is tremendous and immeasurable on patients, families, and societies.
- World 2008
- 12.7 million new cases 7.6 million deaths
- Estimation for 2030: 26 million new cases & 17 million deaths
- - 3 427 388 million new cases 1 867 683 deaths Biggest killers; Lung,Colorectal,Breast &Stomach Cancers
- The big opportunity is 30-40% of cancers are preventable

The European Partnership for Action Against Cancer (EPAAC)

Launched in 2009, after the European Commission published its Communication on Action Against Cancer: European Partnership.

- •Brings together the efforts of different stakeholders into a joint response to prevent and control cancer.
- •Coordinated by the National Institute of Public Health in Slovenia
- Encompasses 36 associated partners from across Europe and over 90 collaborating partners.

Key areas of Action

- Health promotion and prevention (ECL)
- Screening and early detectio (Finnish Cancer Society, the Netherlands)
- Health Care (Spanish "Institut Catala d'Oncologia")
- Cooperation and coordination in cancer research (European CanCer Organisation in cooperation with support of French Cancer Institute)
- Information and data (Italian Instituto Nazionale dei Tumori)

WP5 Health Promotion and Cancer Prevention Objectives

Objective 3

Optimise the use of existing simple but effective tools to communicate proven prevention strategies and campaigns, such as the **European Code Against Cancer**, in the development of media templates, toolkits and templates for adaption for use in Member States.

Objective 4

Target vulnerable population groups, such as women, children, Roma populations.









EPAAC WP5: Key Actions Recap

- Collect cancer prevention toolkits to be rolled out at European and national levels (starting 2012), using proven materials for communicating cancer prevention messages as provided in the evidence-based European Code Against Cancer (www.cancercode.eu)
- Communicate prevention messages during European Week Against Cancer (EWAC) is 25-31 May each year, especially to target groups!
- EWAC includes World No Tobacco Day on 31 May, as vehicle for Health Promotion and Prevention messages, engaging policy-makers at the European, national and subnational levels

DECLARATION OF SUPPORT FOR CANCER PATIENTS

- We, the undersigned, recognise that cancer patients, survivors and family members who need to take time out to care for patients face specific problems in their places of work and need legal protection of their rights to return to satisfactory employment if they so desire.
- And, we the undersigned recognise that cancer patients and survivors are unfairly considered under current legislation, and that the rights of cancer patients to more transparent and fairer access to credit and insurance should be guaranteed.
- Hence, we pledge to:
 - "Call for, at the minimum, a definition of disability as set out by the UN Convention on the rights of people with disabilities, to be implemented in all member states and applied to all existing and proposed EU antidiscrimination legislation"
